Important Terms & Conditions

RENEW CHARITY "2019 TOYS 4KIDS" PROGRAM POLICY/GUIDELINES

Renew Charity is not responsible for any rejected or denied applications due to incomplete application form. We will make 3 attempts to contact each applicant. If we're unsuccessful in contacting the applicant after the third attempt, application will be rejected. It is the applicant responsibility to contact our office within 3 - 7 days regarding application status. Application status can be located on Renew Charity website <https://renewc.org/user/login>

- ✓ Only parent or guardian may register qualifying children. Foster parent must have court documents to prove guardianship alone with full proof of income, i.e. their personal income and not just what they receive from the state for said child. Grandparents must have legal custody of children to register them. Applicant must have birth certificate or verification of birth letter. All registered children must have full name and current age.
- ✓ Children over eighteen (18) years will not be accepted. Your child MUST be between ages 0 - 18. All individual applications must have a copy of verification information attached (i.e. valid ID, child(ren) birth certificate and income); no exceptions. If applicant fails to contact Renew Charity by deadline date, your application will be denied. If any applicant provides false information, the application will be denied.
- ✓ You MUST register by completing Renew Charity form application as the head of household for the "2019 Toys 4Kids" program, or complete and submit an online application before registration deadline.
- ✓ If registrant applied for Christmas assistance with another agency, we MUST be notified.
- ✓ Application form MUST be signed by a parent/guardian and received in our office by deadline.
- ✓ If you have been denied, you have 5 days from the date of denial, to send us a letter in writing explaining the reasons your application should be reviewed for approval.
